## EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0567

Affirmed Ineligible Week 15-24

**PROCEDURAL HISTORY:** On April 17, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from April 7 through 13, 2024 (week 15-24) and was ineligible for benefits for that week (decision # L0003656721). Claimant filed a timely request for hearing. On July 11, 2024, ALJ Fair conducted a hearing and issued Order No. 24-UI-258815, affirming decision # L0003656721. On July 25, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

**FINDINGS OF FACT:** (1) On March 5, 2024, claimant filed an initial claim for unemployment insurance benefits, which was determined to be monetarily valid. Thereafter, claimant filed weekly claims for benefits, including for the week of April 7 through 13, 2024 (week 15-24). This is the week at issue.

(2) Claimant was last employed as a millwright and separated from that employment for medical reasons. During the week at issue, claimant continued to suffer from a variety of medical problems that he felt rendered him temporarily unable to perform millwright work or other types of work. Claimant did not conduct any work-seeking activities or contact any potential employers for work due to these medical problems.

**CONCLUSIONS AND REASONS:** Claimant did not actively seek work during the week at issue.

To be eligible to receive benefits, unemployed individuals must be able to work, available for work, and actively seek work during each week claimed. ORS 657.155(1)(c). With few exceptions that do not apply here, to be actively seeking work as required under ORS 657.155(1)(c), an individual "must conduct at least five work-seeking activities per week," with two of the five work-seeking activities being a direct contact with an employer who might hire the individual. OAR 471-030-0036(5)(a) (March 25, 2022). "Direct contact" means "making contact with an employer in person, by phone, mail, or electronically to inquire about a job opening or applying for job openings in the manner required by the hiring employer." OAR 471-030-0036(5)(a)(B).

Claimant's testimony at hearing did not establish that he conducted any work-seeking activities or had contact with any potential employers during the week at issue. He explained that his doctors had directed that he remain off work for medical reasons from 2023 until at least September 2024. Audio Record at 10:53 to 11:12. Claimant agreed that he had "ceased looking for work" due to his health issues by March 5, 2024, when he filed his initial claim for unemployment insurance benefits. Audio Record at 9:52. Though usually employed as a millwright, claimant testified, "I have not really looked into alternative work, until I can capably do work." Audio Record at 16:05. This further suggests that claimant did not seek work as a millwright, or less physically demanding work, during the week at issue.

While claimant's reasons for not seeking work are understandable given his health problems, the relevant statute and rule nonetheless require that the requisite number of work-seeking activities be conducted during each week as a condition of eligibility for benefits. Because the record does not show that claimant conducted these activities, he was not actively seeking work in accordance with the Department's requirements during the week at issue, and is therefore ineligible for benefits for week 15-24.

**DECISION:** Order No. 24-UI-258815 is affirmed.
