EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0574

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On January 13, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective April 19, 2020 (decision # 61455). On February 2, 2021, decision # 61455 became final without claimant having filed a request for hearing. On December 2, 2021, the Department served notice of an administrative decision, based in part on decision # 61455, concluding that claimant received benefits to which they were not entitled and assessing a total overpayment of \$13,020 in regular unemployment insurance (regular UI) benefits, Pandemic Emergency Unemployment Compensation (PEUC) benefits, and Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department (decision # 93844). On December 22, 2021, decision # 93844 became final without claimant having filed a request for hearing.

On September 17, 2023, claimant filed late requests for hearing on decisions # 61455 and 93844. ALJ Kangas considered the requests, and on September 26, 2023, issued Orders No. 23-UI-236760 and 23-UI-236830, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by October 10, 2023. On October 12, 2023, claimant filed a late response to the appellant questionnaire. On October 16, 2023, ALJ Kangas mailed letters to the parties stating that because the appellant questionnaire response was late, it would not be considered, and no further orders would be issued regarding the matters. Also on October 16, 2023, Orders No. 23-UI-236760 and 23-UI-236830 became final without claimant having filed an application for review of either order with the Employment Appeals Board (EAB). On August 5, 2024, claimant filed late applications for review of Orders No. 23-UI-236760 and 23-UI-236830 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-236760 and 23-UI-236830. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0573 and 2024-EAB-0574).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement accompanying claimant's late applications for review, which has been marked as EAB Exhibit 1, and

claimant's response to the appellant questionnaire, which has been marked as EAB Exhibit 2, and copies provided to the parties with this decision. Any party that objects to our admitting EAB Exhibits 1 and 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibits will remain in the record.

FINDINGS OF FACT: (1) Order No. 23-UI-236760, mailed to claimant on September 26, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-236760 at 2. Order No. 23-UI-236760 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 16, 2023."

(2) Order No. 23-UI-236830, mailed to claimant on September 26, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-236830 at 2. Order No. 23-UI-236830 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 16, 2023, to be timely."

CONCLUSIONS AND REASONS: Claimant's late applications for review are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 23-UI-236760 and 23-UI-236830 were each due by October 16, 2023. Because claimant did not file their applications for review until August 5, 2024, the applications for review were late. Claimant provided a written statement with the applications for review. *See* EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented them from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

DECISION: The applications for review filed August 5, 2024, are dismissed. Orders No. 23-UI-236760 and 23-UI-236830 remain undisturbed.
