EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0581

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 14, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that that claimant failed to provide information to the Department and was ineligible for benefits for the week of November 26 through December 2, 2023 (week 48-23) and until the reason for the denial ended (decision # 94427). On January 3, 2024, decision # 94427 became final without claimant having filed a request for hearing. On March 5, 2024, claimant filed a late request for hearing.

ALJ Kangas considered claimant's request, and on March 14, 2024, issued Order No. 24-UI-250133, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 28, 2024. On March 18, 2024, claimant filed a timely response to the appellant questionnaire. On April 5, 2024, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 24-UI-250133 was vacated and that a hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 94427. On May 20, 2024, ALJ Enyinnaya conducted a hearing, and on May 24, 2024, issued Order No. 24-UI-255008, dismissing claimant's request for hearing as late without good cause. On June 13, 2024, Order No. 24-UI-255008 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 7, 2024, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant submitted with her application for review, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 24-UI-255008, mailed to claimant on May 24, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-255008 at 4.

Order No. 24-UI-255008 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 13, 2024, to be timely."

(2) On August 7, 2024, claimant filed a late application for review with the EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-255008 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-255008 was due by June 13, 2024. Because claimant did not file her application for review until August 7, 2024, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe circumstances preventing her from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

DECISION: The application for review filed August 7, 2024, is dismissed. Order No. 24-UI-255008 remains undisturbed.
