EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0582

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 8, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was disqualified from receiving unemployment insurance benefits effective October 29, 2023 (decision # 70859). Claimant filed a timely request for hearing. On March 5, 2024, ALJ Fraser convened a hearing but did not take evidence, as the parties agreed to continue the matter to March 21, 2024. On March 21, 2024, ALJ Fraser conducted a hearing, and on March 22, 2024, issued Order No. 24-UI-250782, affirming decision # 70859. On April 11, 2024, Order No. 24-UI-250782 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 31, 2024, claimant filed a late application for review of Order No. 24-UI-250782 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with her application for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 24-UI-250782, mailed to claimant on March 22, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-250782 at 6. Order No. 24-UI-250782 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 11, 2024, to be timely."

(2) On July 31, 2024, claimant filed a late application for review with the EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-250782 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-250782 was due by April 11, 2024. Because claimant did not file her application for review until July 31, 2024, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented her from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 31, 2024, is dismissed. Order No. 24-UI-250782 remains undisturbed.
