

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0588**

*Late Application for Review Dismissed Without Prejudice*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On May 15, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 7, 2024 (decision # L0004052559). Claimant filed a timely request for hearing. On July 9, 2024, ALJ Gutman conducted a hearing, and on July 11, 2024, issued Order No. 24-UI-258788, modifying decision # L0004052559 by concluding claimant voluntarily quit work without good cause and was disqualified from receiving benefits effective March 24, 2024.<sup>1</sup> On July 31, 2024, Order No. 24-UI-258788 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 8, 2024, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with her application for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** The application for review is dismissed without prejudice.

On August 8, 2024, the appellant filed an application for review of Order No. 24-UI-258788 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than July 31, 2024. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes she had good cause and filed her late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is August 20, 2024, *and*
2. The appellant must include a statement on the request for reconsideration declaring that she sent a copy of the request to the other party, *and*
3. The appellant must provide additional specific details about the reason she filed a late application for review. For example, the appellant should include specific information about the date she received the ALJ's order (Order No. 24-UI-258788), whether she read it, whether she agreed or disagreed with the ALJ's order, the reason(s) why she did not file the application for review by the July 31, 2024, the deadline, and how the reason(s) affected her ability to file a timely application for review.

If the appellant asserts that she attempted to file an application for review of Order No. 24-UI-258788 with EAB via the Department's Frances Online system, the appellant should specify when she made those attempts. If the appellant used Frances Online to attempt to file an application for review with EAB, the appellant should also indicate if she ever specifically requested review of Order No. 24-UI-258788 on any of the web pages or screens she encountered on Frances Online or if she used Frances Online in some other manner that expressed an intent to appeal Order No. 24-UI-258788, and, if so, precisely how. If the appellant asserts that she attempted to file an application for review of Order No. 24-UI-258788 with EAB via the Department's Frances Online system, the appellant should also explain why she decided to file an application for review with EAB via Frances Online rather than by mailing or faxing a paper application for review form to EAB or filing an application for review with EAB via the webform on EAB's website.

The appellant should describe any other specific details that might help EAB determine whether the appellant had "good cause," which means factors or circumstances beyond her reasonable control prevented them from filing a timely application for review, *and*

4. The appellant must provide the date the circumstances that prevented her from filing a timely application for review (which she listed in response to #3, above) ceased to exist, *and*
5. The appellant must provide sufficient information to prove that she filed her application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

1. Use your smart phone, tablet, or computer to fill out the “File a Written Argument” form, available on EAB’s website: <https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx>, *or*
2. Use your smart phone, tablet, or computer to send an email to EAB at [OED\\_EAB\\_OFFICE@employ.oregon.gov](mailto:OED_EAB_OFFICE@employ.oregon.gov), *or*
3. Send the request by U.S. mail or another delivery service, addressed to 875 Union St NE, Salem, Oregon 97311, *or*
4. Send EAB a fax at 503-378-2129.

**DECISION:** The application for review filed August 8, 2024, is dismissed without prejudice. Order No. 24-UI-258788 remains undisturbed.
