EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0621

Application for Review Dismissed

PROCEDURAL HISTORY: On July 2, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from March 17 through 30, 2024 (weeks 12-24 through 13-24) and was ineligible for benefits for those weeks (decision # L0004891847). Claimant filed a timely request for hearing. On July 26, 2024, ALJ Enyinnaya conducted a hearing, and on August 1, 2024, issued Order No. 24-UI-261099, affirming decision # L0004891847. On August 21, 2024, Order No. 24-UI-261099 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 23, 2024, claimant filed a late application for review of Order No. 24-UI-261099 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's application for review and the postmarked envelope in which it was mailed, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 24-UI-261099, mailed to claimant on August 1, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-261099 at 3. Order No. 24-UI-261099 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before August 21, 2024, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-261099 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-261099 was due by August 21, 2024. Because claimant did not file his application for review until August 23, 2024,¹ the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented him from filing the application for review by the August 21, 2024, deadline. EAB Exhibit 1 at 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed August 23, 2024, is dismissed. Order No. 24-UI-261099 remains undisturbed.
