

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0622

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 23, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for committing a disqualifying act under the Department’s drug, cannabis, and alcohol adjudication policy, disqualifying claimant from receiving unemployment insurance benefits effective December 10, 2023 (decision # L0004286135).¹ On June 12, 2024, decision # L0004286135 became final without claimant having filed a request for hearing. On July 28, 2024, claimant filed a late request for hearing on decision # L0004286135.

ALJ Kangas considered claimant’s request, and on August 1, 2024, issued Order No. 24-UI-261056, dismissing claimant’s request for hearing as late, subject to claimant’s right to renew the request by responding to an appellant questionnaire by August 15, 2024. On August 20, 2024, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 24-UI-261056 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant’s response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

¹ Decision # L0004286135 stated that claimant was denied benefits from January 21, 2024 to January 18, 2025. However, the end date of the disqualification appears to be error because disqualifications from benefits under ORS 657.176 continue until the individual has earned, subsequent to the week in which the disqualification began, four times their weekly benefit amount in subject employment. *See* ORS 657.176(2). As such, it is presumed that the Department intended to disqualify claimant from benefits beginning December 10, 2023, the Sunday of the week of their December 14, 2023 work separation, and until they earned four times their weekly benefit amount in subject employment.

FINDINGS OF FACT: (1) On May 23, 2024, the Department mailed decision # L0004286135 to claimant’s address on file with the Department. Decision # L0004286135 stated, “You have the right to appeal our decision and request a hearing if you believe our decision is wrong. We must receive your request for a hearing no later than **June 12, 2024.**” Exhibit 1 at 2 (emphasis in original).

(2) On July 28, 2024, claimant used Frances Online to file a late request for hearing. Exhibit 2 at 1, 2; EAB Exhibit 1 at 1.

CONCLUSIONS AND REASONS: Claimant’s late request for hearing is dismissed.

ORS 657.269 provides that the Department’s decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a “reasonable time” upon a showing of “good cause.” OAR 471-040-0010 (February 10, 2012) provides that “good cause” includes factors beyond an applicant’s reasonable control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

The deadline to file a request for hearing on decision # L0004286135 was June 12, 2024. Because claimant filed their request for hearing on July 28, 2024, the request for hearing was late.

In claimant’s appellant questionnaire response, claimant stated that they received decision # L0004286135 on May 24, 2024, but did not file a request for hearing until July 28, 2024. EAB Exhibit 1 at 1. Claimant also asserted that they “absolutely . . . met deadline” but stated, contradictorily, that the reason they did not file a hearing request before the deadline stated in decision # L0004286135 was because of “Frances Online.” EAB Exhibit 1 at 2. Claimant’s appellant questionnaire response suggested that claimant encountered difficulties using the Department’s Frances Online system, in that claimant states, “This journey began on 1/21/24 when I was eligible for benefits. 6 months & a bunch of crap with Frances until they final get that right[.]” EAB Exhibit 1 at 1. However, claimant did not indicate why, how, or precisely when they encountered difficulties using Frances Online, either to file a request for hearing or otherwise.

Given that claimant conceded that they received decision # L0004286135 shortly after it was mailed, stated that Frances Online was the reason they did not appeal by June 12, 2024, but offered no details as to how or why this was the case, claimant failed to establish good cause to extend the deadline to request a hearing on decision # L0004286135. Therefore, claimant’s late request for hearing on decision # L0004286135 must be dismissed under ORS 657.875 and OAR 471-040-0010.

DECISION: Order No. 24-UI-261056 is affirmed.
