# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0623

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On May 2, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the week of February 25, 2024, through March 2, 2024 (week 09-24) and was therefore ineligible to receive unemployment insurance benefits for that week (decision # L0003884630). On May 22, 2024, decision # L0003884630 became final without claimant having filed a request for hearing. On July 9, 2024, claimant filed a late request for hearing on decision # L0003884630.

ALJ Kangas considered claimant's request, and on July 18, 2024, issued Order No. 24-UI-259578, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 1, 2024. On August 7, 2024, Order No. 24-UI-259578 became final without claimant having responded to the appellant questionnaire or having filed an application for review of the order with the Employment Appeals Board (EAB). On August 23, 2024, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 24-UI-259578 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire and an enclosed written statement, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 24-UI-259578, mailed to claimant on July 18, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-259578 at 2. Order No. 24-UI-259578 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than August 7, 2024."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-259578 is dismissed.

An application for review to the Employment Appeals Board is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-259578 was due by August 7, 2024. Because claimant did not file their application for review of Order No. 24-UI-259578 until August 23, 2024, the application for review was late. Claimant provided a written statement with the application for review, in the form of a response to the appellant questionnaire and an attached written statement. However, although these documents describe why claimant did not file their request for hearing on decision # L0003884630 late, they did not describe circumstances that prevented claimant from filing the application for review of Order No. 24-UI-259578 to the Employment Appeals Board on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review of Order No. 24-UI-259578 is dismissed.

**DECISION:** The application for review filed August 23, 2024, is dismissed. Order No. 24-UI-259578 remains undisturbed.
