EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0635

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 9, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective June 2, 2024 (decision # L0005012354). Claimant filed a timely request for hearing. On August 2 and 6, 2024, ALJ Contreras conducted a hearing, and on August 9, 2024, issued Order No. 24-UI-262064, reversing decision # L0005012354 by concluding that claimant was discharged, but not for misconduct, and not disqualified from receiving benefits based on the work separation. On August 29, 2024, Order No. 24-UI-262064 became final without the employer having filed an application for with the Employment Appeals Board (EAB). On September 3, 2024, the employer filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement the employer filed with their application for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 24-UI-262064, mailed to claimant on August 9, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-262064 at 4. Order No. 24-UI-262064 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before August 29, 2024, to be timely."

(2) On September 3, 2024, the employer filed their application for review.

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. 24-UI-262064 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-262064 was due August 29, 2024. Because the employer did not file their application for review until September 3, 2024, the application for review was late. The employer provided a written statement with the application for review. However, the employer's written statement did not describe circumstances preventing the employer from filing the application for review on time. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The application for review filed September 3, 2024, is dismissed. Order No. 24-UI-262064 remains undisturbed.
