EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0642

Applications for Review Dismissed

PROCEDURAL HISTORY: On June 18, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the week of June 16, 2024 through June 22, 2024 (week 25-24) and until the reason for the denial had ended (decision # L0004526486). Also on June 18, 2024, the Department served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the week of May 26, 2024 through June 1, 2024 (week 22-24) and until the reason for the denial had ended (decision # L0004880808). Claimant filed a timely request for hearing on each decision.

On August 26, 2024, ALJ Chiller conducted a consolidated hearing at which the Department failed to appear, and on September 3, 2024, issued Orders No. 24-UI-264611 and 24-UI-264613. Order No. 24-UI-264611 modified decision # L0004526486 by concluding that claimant failed to provide information and was ineligible to receive benefits for the weeks of June 16, 2024 through August 24, 2024 (weeks 25-24 through 34-24), and Order No. 24-UI-264613 modified decision # L0004880808 by concluding that claimant failed to register for work and was eligible to receive benefits for the weeks of May 26, 2024 through June 15 2024 (weeks 22-24 through 24-24) but was ineligible to receive benefits for weeks 25-24 through 34-24. On September 11, 2024, claimant filed applications for review of Orders No. 24-UI-264611 and 24-UI-264613 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-264611 and 24-UI-264613. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0642 and 2024-EAB-0643).

¹ Decision # L0004526486 stated that the ineligibility period began on June 17, 2024. However, as benefit weeks begin on Sundays and June 17, 2024, was a Monday, it is presumed that the Department intended that the disqualification begin on Sunday, June 16, 2024.

FINDING OF FACT: (1) On September 16, 2024, claimant sent an email to EAB asking to withdraw her applications for review of Orders No. 24-UI-264611 and 24-UI-264613 because the Department amended decisions # L0004526486 and L0004880808 to decisions allowing benefits, and paid claimant benefits for the weeks that had been denied by the orders under review.

CONCLUSIONS AND REASONS: Claimant's applications for review are dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

On September 16, 2024, EAB received a written request, by email, in which claimant withdrew the applications for review of Orders No. 24-UI-264611 and 24-UI-264613. EAB had not yet issued a decision in either matter. Therefore, under OAR 471-041-0098, claimant's request to withdraw the applications for review is allowed.

DECISION: The applications for review filed September 11, 2024, are dismissed.
