

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0646**

*Late Application for Review Dismissed Without Prejudice*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On April 24, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of April 2, 2023, through April 8, 2023 (week 14-23), and until the reason for the denial had ended. On May 15, 2023, the April 24, 2023, administrative decision became final without claimant having filed a request for hearing. On May 31, 2023, claimant filed a late request for hearing.

ALJ Kangas considered claimant's request, and on November 6, 2023, issued Order No. 23-UI-240412, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 20, 2023. On November 27, 2023, Order No. 23-UI-240412 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On September 5, 2024, claimant sent an email to the Office of Administrative Hearings (OAH) that EAB construed as an application for review of Order No. 23-UI-240412.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is an email communication claimant sent to OAH, which amounts to claimant's written statement submitted with their application for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must send the objection to EAB in writing, explaining the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** The application for review is dismissed without prejudice.

On September 5, 2024, claimant filed an application for review of Order No. 23-UI-240412 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than

November 27, 2023. Claimant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time if the applicant can show they have good cause to extend the deadline. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If claimant believes they have good cause and filed their late application for review within a reasonable time, claimant may ask EAB to reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. Claimant must file the request for reconsideration by October 17, 2024, *and*
2. Claimant must state in the request for reconsideration that they sent a copy of the request to the other party, *and*
3. Claimant must provide additional specific details about the reason they filed a late application for review. For example, claimant should include specific information about the date they received the ALJ's Order No. 23-UI-240412, whether they read and disagreed with it, and how they were prevented from filing their application for review by November 27, 2023. Claimant should include specific details that might help EAB determine whether claimant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
4. Claimant must provide the date the circumstances that prevented them from filing a timely application for review ended (the circumstances they listed in response to #3, above), *and*
5. Claimant must provide sufficient information to prove that they filed their application for review within **seven** days of the date the circumstances that prevented them from filing a timely application for review ended.

There are several ways to file a request for reconsideration:

Please note that you need only file *one* request for reconsideration.

**DECISION:** The application for review filed September 5, 2024, is dismissed without prejudice. Order No. 23-UI-240412 remains undisturbed.
