EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0676

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 14, 2020, the Oregon Employment Department (the Department) served notice of a wage and potential benefit report (WPBR) concluding that claimant had insufficient earnings to establish a claim for regular unemployment insurance (regular UI) benefits. On December 24, 2020, the December 14, 2020, WPBR became final without claimant having filed a request for hearing. On May 25, 2024, claimant filed a late request for hearing. ALJ Kangas considered the request, and on September 5, 2024, issued Order No. 24-UI-265025, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 19, 2024. On September 20, 2024, claimant filed a late appellant questionnaire response and a timely application for review with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's appellant questionnaire response and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) The December 14, 2020, WPBR, mailed to claimant's address of record on file with the Department on that date, stated, "This report becomes final unless you request redetermination of the report or request a hearing within 10 days." Exhibit 1 at 26.

(2) In 2020, claimant "was homeless with no mailing address or internet[.]" EAB Exhibit 1 at 1. Claimant therefore did not receive the December 14, 2020, WPBR when it was mailed.

(3) On or around May 1, 2024, claimant received a copy of the December 14, 2020, WPBR.

(4) On May 25, 2024, claimant filed a request for hearing that was construed as a late request for hearing on the December 14, 2020, WPBR.¹

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.266(5) provides that the Department's initial determination on a new claim for benefits becomes final unless a party files a request for hearing within 10 days after the date the determination is mailed. ORS 657.875 provides that the 10-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake and defines "reasonable time" as seven days after those factors ceased to exist.

The 10-day deadline for claimant to file a request for hearing on the December 14, 2020, WPBR was December 24, 2020. Because claimant did not request a hearing until May 25, 2024, the request was late. Claimant wrote in their appellant questionnaire response that they received the December 14, 2020, WPBR "approximately 05/01/2024." EAB Exhibit 1 at 1. Claimant also wrote, "In 2020 I was homeless with no mailing address or internet so I knew nothing of the original decision." EAB Exhibit 1 at 1.

Even assuming that claimant failed to timely receive the December 14, 2020, WPBR in the mail due to circumstances beyond claimant's reasonable control, which prevented timely filing of a request for hearing, it can reasonably be inferred that these circumstances ended no later than May 1, 2024, when claimant received a copy of the WPBR. As claimant's late request for hearing was filed more than seven days later, on May 25, 2024, it was not filed within a "reasonable time" after the circumstances that prevented timely filing ended. Therefore, even if good cause existed to extend the deadline for timely filing, claimant's late request for hearing is subject to dismissal because it was not filed within a reasonable time.

For these reasons, claimant's late request for hearing on the December 14, 2020, WPBR is dismissed.

DECISION: Order No. 24-UI-265025 is affirmed.

¹ It appears from claimant's late request for hearing that claimant may have instead intended to appeal a May 4, 2021, Notice of Determination for Pandemic Unemployment Assistance (PUA) which concluded that he was ineligible for PUA benefits effective December 27, 2020, due to failing to provide documentary proof of employment or self-employment. Claimant may wish to file a late request for hearing on that decision if claimant believes that they have good cause for the late filing and files the request within a seven-day "reasonable time" after the circumstances that prevented timely filing ended.
