# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0693

Late Application for Review Dismissed No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 9, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the weeks of October 29, 2023, through December 30, 2023 (weeks 44-23 through 52-23) and was therefore ineligible to receive unemployment insurance benefits for those weeks and until the reason for the denial had ended (decision # 70128). Claimant filed a timely request for hearing. On February 27, 2024, ALJ Janzen conducted a hearing at which the employer and the Department failed to appear, and issued Order No. 24-UI-248935, reversing decision # 70128 by concluding that claimant was available for work during weeks 44-23 through 52-23 and was eligible to receive benefits for those weeks on that basis. On March 18, 2024, Order No. 24-UI-248935 became final without the employer or the Department having filed an application for review with the Employment Appeals Board (EAB). On September 20, 2024, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-248935 presents no justiciable controversy and is dismissed.

On September 20, 2024, claimant filed with EAB a late application for review of an order that allowed claimant benefits during the weeks of October 29, 2023, through December 30, 2023 (weeks 44-23 through 52-23) based on claimant's availability to work. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's late application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the late application for review is dismissed and Order No. 24-UI-248935 remains undisturbed.<sup>1</sup>
