EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0721

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 15, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective January 28, 2024 (decision # L0003546055). Claimant filed a timely request for hearing. On May 30, 2024, ALJ Christon conducted a hearing, and on June 7, 2024, issued Order No. 24-UI-256075, affirming decision # L0003546055 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective January 28, 2024. On June 27, 2024, Order No. 24-UI-256075 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 12, 2024, claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 24-UI-256075, mailed to claimant on June 7, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-256075 at 4. Order No. 24-UI-256075 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 27, 2024, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-256075 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

¹ Decision # L0003546055 stated that claimant quit work without good cause on January 30, 2024. The decision stated that claimant was denied benefits based on the work separation but left the effective date of the disqualification blank. The failure to fill in the date of the disqualification is presumed to be a typographical error. The decision is presumed to have meant to list January 28, 2024 as the date of disqualification.

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-256075 was due by June 27, 2024. Because claimant did not file her application for review until October 12, 2024, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing her from filing the application for review by the June 27, 2024, deadline. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

DECISION: The application for review filed October 12, 2024, is dismissed. Order No. 24-UI-256075 remains undisturbed.
