EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0730

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 2, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits beginning April 14, 2024, and until the reason for the denial ended (decision # L0003952388). On May 22, 2024, decision # L0003952388 became final without claimant having filed a request for hearing. On July 25, 2024, claimant filed a late request for hearing. ALJ Kangas considered the request, and on July 30, 2024, issued Order No. 24-UI-260749 dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 13, 2024. On August 7, 2024, claimant filed a timely appellant questionnaire response. ALJ Scott considered the response, and on October 10, 2024, issued Order No. 24-UI-268974, re-dismissing claimant's request for hearing as late without good cause, leaving decision # L0003952388 undisturbed. On October 16, 2024, claimant filed an application for review of Order No. 24-UI-268974 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Under ORS 657.275(2) and OAR 471-041-0090(1)(b)(A) (May 13, 2019), EAB did not consider claimant's argument because it was not relevant and material to EAB's determination of whether to allow claimant's late request for hearing on decision # L0003952388.

FINDING OF FACT: (1) Decision # L0003952388, mailed to claimant's address of record on file with the Department on May 2, 2024, stated, "You have the right to appeal our decision and request a hearing if you believe our decision is wrong. We must receive your request for a hearing no later than **May 22**, **2024**." Exhibit 1 at 2 (emphasis in original). Claimant's request for hearing was filed on July 25, 2024.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed. ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day

deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on decision # L0003952388 was due by May 22, 2024. Because claimant filed their request for hearing on July 25, 2024, the request was late. Claimant was given the opportunity to explain why the request for hearing was filed late by responding to an appellant questionnaire. However, claimant's response concerned only claimant's failure to appear for a hearing in another matter, and did not address what factors, if any, prevented timely filing of the request for hearing on decision # L0003952388. Exhibit 3 at 1. Good cause has not been shown to extend the deadline for timely filing, and the late request for hearing is dismissed.

DECISION: Order No. 24-UI-268974 is affirmed.
