# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0736

# Application for Review Dismissed

**PROCEDURAL HISTORY:** On December 19, 2023, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report (WPBR) concluding that claimant was entitled to a weekly benefit amount of \$363 and a maximum benefit amount of \$9,438. On December 29, 2023, the December 19, 2023 WPBR became final without claimant having filed a request for hearing. On May 27, 2024, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 29, 2024 issued Order No. 24-UI-264346, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 12, 2024. On September 18, 2024, Order No. 24-UI-264346 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On October 17, 2024, claimant filed a late application for review of Order No. 24-UI-264346 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written statement on the late application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 24-UI-264346, mailed to claimant on August 29, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-264346 at 2. Order No. 24-UI-264346 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 18, 2024.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-264346 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-264346 was due by September 18, 2024. Because claimant did not file their application for review until October 17, 2024, the application for review was late. Claimant provided a written statement on the application for review, in the form of an email that claimant sent to EAB on October 17, 2024.<sup>1</sup> However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed October 17, 2024 is dismissed. Order No. 24-UI-264346 remains undisturbed.
