

**EMPLOYMENT APPEALS BOARD DECISION**  
**2024-EAB-0767**

*Late Application for Review Dismissed Without Prejudice*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On November 29, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an \$855 overpayment that claimant was required to repay to the Department, a \$213.75 monetary penalty, and a five-week penalty disqualification from future benefits (decision # 195823). On December 19, 2022, decision # 195823 became final without claimant having filed a request for hearing. On July 24, 2024, claimant filed a late request for hearing on decision # 195823. ALJ Scott considered claimant's request, and on September 10, 2024 issued Order No. 24-UI-265570, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 24, 2024. On September 30, 2024, Order No. 24-UI-265570 became final without claimant having filed an appellant questionnaire response or an application for review with the Employment Appeals Board (EAB). On October 29, 2024, claimant filed a late appellant questionnaire response and a late application for review of Order No. 24-UI-265570 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with their application for review, including claimant's appellant questionnaire response. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** The application for review is dismissed without prejudice.

On October 29, 2024, claimant filed an application for review of Order No. 24-UI-265570 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than September 30, 2024. Claimant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time if the applicant can show they have good cause to extend the deadline. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If claimant believes they have good cause and filed their late application for review within a reasonable time, claimant may ask EAB to reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. Claimant must file the request for reconsideration by December 2, 2024, *and*
2. Claimant must state in the request for reconsideration that they sent a copy of the request to the other party (Copiers Northwest), *and*
3. Claimant must provide additional specific details about the reason they filed a late application for review. For example, claimant should include specific information about the date they received the ALJ's Order No. 24-UI-265570 which dismissed claimant's late request for hearing on decision # 195823, whether they read and disagreed with it, and how they were prevented from filing their application for review by September 30, 2024. Claimant should include specific details that might help EAB determine whether or not claimant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
4. Claimant must provide the date the circumstances that prevented them from filing a timely application for review ended (the circumstances they listed in response to #3, above), *and*
5. Claimant must provide sufficient information to prove that they filed their application for review within **seven** days of the date the circumstances that prevented them from filing a timely application for review ended.

There are several ways to file a request for reconsideration:

Please note that you need only file *one* request for reconsideration.

**DECISION:** The application for review filed October 29, 2024 is dismissed without prejudice. Order No. 24-UI-265570 remains undisturbed.
