EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0770

Late Application for Review Dismissed

PROCEDURAL HISTORY: On May 9, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible for unemployment insurance benefits for the week beginning May 5, 2024 (week 19-24) and until the reason for the denial had ended (decision # L0004033473). On May 29, 2024, decision # L0004033473 became final without claimant having filed a request for hearing. On July 14, 2024, claimant filed a late request for hearing on decision # L0004033473.

ALJ Kangas considered claimant's request, and on July 17, 2024, issued Order No. 24-UI-259359, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 31, 2024. On July 31, 2024, claimant filed a timely response to the appellant questionnaire. On October 10, 2024, ALJ Scott issued Order No. 24-UI-268940, canceling Order No. 24-UI-259359, re-dismissing claimant's request for hearing on decision # L0004033473 as late without good cause, and leaving # L0004033473 undisturbed. On October 30, 2024, Order No. 24-UI-268940 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 3, 2024, claimant filed a late application for review of Order No. 24-UI-268940 with EAB.

FINDINGS OF FACT: (1) Order No. 24-UI-268940, mailed to claimant on October 10, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-268940 at 3. Order No. 24-UI-268940 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 30, 2024, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-268940 is dismissed.

¹ Decision # L0004033473 stated that claimant was denied benefits beginning May 8, 2024. However, decision # L0004033473 should have stated that claimant was ineligible to receive benefits beginning Sunday, May 5, 2024 because benefit weeks begin on Sundays.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-268940 was due by October 30, 2024. Because claimant did not file their application for review until November 3, 2024, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the October 30, 2024, deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed November 3, 2024 is dismissed. Order No. 24-UI-268940 remains undisturbed.
