

EMPLOYMENT APPEALS BOARD DECISION
2024-EAB-0771

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 13, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to provide information to verify her identity and was ineligible for benefits effective August 4, 2024 (decision # L0005748292). On September 3, 2024, decision # L0005748292 became final without claimant having filed a request for hearing. On September 9, 2024, claimant filed a late request for hearing. ALJ Kangas considered the request, and on September 17, 2024, issued Order No. 24-UI-266337, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 1, 2024. On October 7, 2024, Order No. 24-UI-266337 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On November 3, 2024, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's late application for review and written statement describing the circumstances that prevented a timely filing and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record. Under ORS 657.275(2) and OAR 471-041-0090(1)(b)(A), other information included with the application for review, including medical records, was not considered because the information was not relevant to the issue of whether claimant's late application for review should be allowed.

FINDINGS OF FACT: (1) Order No. 24-UI-266337, mailed to claimant on September 17, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-266337 at 2. Order No. 24-UI-266337 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 7, 2024." Claimant did not receive Order No. 24-UI-266337 until October 26, 2024.

(2) On November 3, 2024, claimant filed a late application for review of Order No. 24-UI-266337 with EAB.

CONCLUSIONS AND REASONS: Claimant’s late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-266337 was due by October 7, 2024. Because claimant’s application for review was filed on November 3, 2024, it was late. Claimant stated in their late application for review, “USPS clearly isn’t working – I received 0 mail until Oct 26, 2024.” EAB Exhibit 1 at 1. It can reasonably be inferred from this statement that claimant was prevented from timely filing the application for review because they received Order No. 24-UI-266337 on October 26, 2024, after the deadline for timely filing had passed. However, even if this was a circumstance beyond claimant’s reasonable control, the circumstance ended more than seven days before claimant filed their late application for review on November 3, 2024. Claimant’s late application for review therefore was not filed within a “reasonable time,” even if good cause exists to extend the deadline for timely filing. Accordingly, claimant’s late application for review is dismissed.

DECISION: The application for review filed November 3, 2024 is dismissed. Order No. 24-UI-266337 remains undisturbed.
