EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0777

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On March 30, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer, but not for misconduct, and not disqualified from receiving benefits based on the work separation (decision # 114416). The employer filed a timely request for hearing. On April 24, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 9, 2023. On May 9, 2023, the employer failed to appear at the hearing, and ALJ Griffin issued Order No. 23-UI-224335, dismissing the employer's request for hearing due to their failure to appear. On May 12, 2023, the employer filed a timely request to reopen the hearing. ALJ Kangas considered the request, and on September 19, 2023, issued Order No. 23-UI-236201, denying the reopen request as without good cause, leaving Order No. 23-UI-224335 undisturbed. On October 9, 2023, the employer filed an application for review of Order No. 23-UI-236201 with EAB.

WRITTEN ARGUMENT: The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the record and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information with their request to reopen the hearing as required by OAR 471-040-0040(3) (February 10, 2012). The argument also is not relevant and material to EAB's determination of whether to allow the employer's request to reopen the May 9, 2023, hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the record when reaching this decision.

FINDING OF FACT: The employer's request for a reopening did not state the employer's reason(s) for failing to appear at the May 9, 2023, hearing.

CONCLUSIONS AND REASONS: The employer's request to reopen the hearing is denied.

¹ The employer filed their request to reopen the hearing with EAB on an Application for Review form. Exhibit 5 at 2. As explained in that form, the application for review was treated as a request to reopen the hearing under OAR 471-041-0060(4). Exhibit 5 at 2.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's reasonable control. OAR 471-040-0040(2) (February 10, 2012). The party requesting reopening shall set forth the reason(s) for missing the hearing in a written statement, which the Office of Administrative Hearings (OAH) shall consider in determining whether good cause exists for failing to appear at the hearing. OAR 471-040-0040(3).

The employer failed to appear at the May 9, 2023, hearing. However, the employer did not include with their reopen request a written statement stating the employer's reason(s) for missing the hearing, as required under OAR 471-040-0040(3). The employer therefore has not shown that they had good cause for failing to appear at the hearing. Under OAR 471-040-0040(3) and (4), the employer's request to reopen the hearing is denied. Order No. 23-UI-224335 and decision # 114416 remain undisturbed.

DECISION: Order No. 23-UI-236201 is affirmed.
