# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0787

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On September 11, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and therefore was disqualified from receiving unemployment insurance benefits effective August 18, 2024 (decision # L0005977349). Claimant filed a timely request for hearing. On October 16, 2024, ALJ Parnell conducted a hearing at which the employer failed to appear, and on October 18, 2024, issued Order No. 24-UI-270016, affirming decision # L0005977349. On November 7, 2024, Order No. 24-UI-270016 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 8, 2024, claimant filed a late application for review of Order No. 24-UI-270016 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's statement submitted with his application for review, has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 24-UI-270016, mailed to claimant on October 18, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-270016 at 3. Order No. 24-UI-270016 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 7, 2024, to be timely."

However, decision # L0005977349 should have stated that claimant was disqualified from receiving benefits beginning Sunday, August 18, 2024, and until he earned four times his weekly benefit amount. *See* ORS 657.176.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-270016 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-270016 was due by November 7, 2024. Because claimant did not file his application for review until November 8, 2024, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented him from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed November 8, 2024 is dismissed. Order No. 24-UI-270016 remains undisturbed.
