## EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0816

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On May 7, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective March 31, 2024 (decision # L0003959838). Claimant filed a timely request for hearing. On October 14, 2024, ALJ Frank conducted a hearing, and on October 22, 2024, issued Order No. 24-UI-270307, affirming decision # L0003959838. On November 12, 2024, Order No. 24-UI-270307 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 25, 2024, claimant filed a late application for review of Order No. 24-UI-270307 with EAB.

**FINDING OF FACT:** Order No. 24-UI-270307, mailed to claimant on October 22, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-270307 at 4. Order No. 24-UI-270307 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 12, 2024, to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 24-UI-270307 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-270307 was due by November 12, 2024. Because claimant did not file her application for review until November 25, 2024, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing her from filing the application for review by the November 12, 2024, deadline. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

**DECISION:** The application for review filed November 25, 2024 is dismissed. Order No. 24-UI-270307 remains undisturbed.
