## EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0825

Affirmed
Ineligible Weeks 42-24 through 46-24

**PROCEDURAL HISTORY:** On October 22, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register for work following the Department's rules and therefore was ineligible to receive unemployment insurance benefits effective October 13, 2024 (week 42-24) and until the reason for the denial had ended (decision # L0006760296). Claimant filed a timely request for hearing. On November 18, 2024, ALJ Lucas conducted a hearing at which the Department failed to appear, and on November 20, 2024 issued Order No. 24-UI-274043, modifying decision # L0006760296 by concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible for benefits for the weeks of October 13, 2024 through November 16, 2024 (weeks 42-24 through 46-24). On December 3, 2024, claimant filed an application for review with the Employment Appeals Board (EAB).

**FINDINGS OF FACT:** (1) On October 6, 2024, claimant filed an initial claim for unemployment insurance benefits. Claimant subsequently claimed benefits for the weeks of October 13, 2024, through November 16, 2024 (weeks 42-24 through 46-24). These are the weeks at issue. The Department did not pay claimant benefits for the weeks at issue.

(2) On October 4, 2024, the Department mailed claimant a letter entitled "Reemployment Services and Eligibility Assessment." Exhibit 2 at 1. The letter included a list of tasks that claimant was required to complete to be eligible for benefits. In relevant part, the list included the following requirements:

<sup>&</sup>lt;sup>1</sup> Department records indicate that the Department also issued an administrative decision on October 21, 2024, which denied claimant benefits effective October 13, 2024 on the basis that she had failed to verify her identity following the Department's rules (decision # L0006707592). It does not appear that claimant has since completed that requirement. Claimant should be aware that the denial of benefits on that basis may continue until she completes that requirement. Additionally, it does not appear that claimant's request for hearing on decision # L0006760296 was also treated as a request for hearing on decision # L0006707592. As such, if claimant wishes to challenge the determination in decision # L0006707592, she should contact the Department to file a request for hearing on that decision.

- Complete your iMatchSkills registration at imatchskills.org.
- Meet one-on-one with a WorkSource Oregon Employment Specialist for your orientation. Call or visit a WorkSource Oregon center using the information below, or go to worksourceoregon.org/contact to schedule an appointment.

Exhibit 2 at 1. The letter also stated, "You must complete your identity verification, registration, and orientation no later than October 17, 2024. Your benefits will be denied if you don't complete the above steps by this due date." Exhibit 2 at 2. At some point prior to October 17, 2024, claimant received the October 4, 2024, letter via her Frances Online account.

- (3) On October 9, 2024, claimant's daughter was severely injured in a motor vehicle accident, causing claimant significant emotional distress and requiring her to care for her daughter while she recovered. Around the same time, claimant's son was in the process of enlisting in the army, and required claimant's help with the process. The combination of these circumstances consumed most of claimant's focus at the time. As a result, claimant did not read the October 4, 2024, letter, register with iMatchSkills, or complete her orientation at WorkSource Oregon by the October 17, 2024 deadline.
- (4) As of November 18, 2024, claimant had not yet completed the above requirements listed in the October 4, 2024, letter.

**CONCLUSIONS AND REASONS:** Claimant failed to register for work in accordance with the Department's rules and therefore is ineligible for benefits for the weeks at issue.

ORS 657.155(1)(a) states that an unemployed individual is eligible to receive benefits only if the individual has registered for work and thereafter continued to report at an employment office in accordance with Department rules. ORS 657.159(1) states that to satisfy the registration requirement of ORS 657.155(1) an individual shall submit such information regarding the individual's job qualifications, training and experience as the Department requests.

OAR 471-020-0020 (August 8, 2004) states in relevant part:

(1)(a) Except for individuals identified in OAR 471-020-0021, all unemployment insurance claimants shall submit such information as may be required by the Oregon Employment Department to carry out job placement services for the individual including, but not limited to, the individual's job qualifications, training and experience. Such information shall be entered into the Business & Employment Services online job match system concurrent with, or as soon as possible following, the filing of an initial claim for unemployment insurance benefits. Entry of this information shall constitute enrollment.

\* \* \*

OAR 471-030-0035 (January 11, 2018) states in relevant part:

- (1) A claimant may fulfill the "registered for work" requirements of ORS 657.155(1)(a) by completion of such processes as directed by the Director in order to create a full registration for work.
- (2) "Full registration for work" as used in this rule, means providing information regarding the individual's job qualifications, skills, training and experience as the Director or an authorized representative of the Director deems necessary to carry out job placement services for the individual.

\* \* \*

The Department denied claimant benefits for the weeks at issue because she did not complete her iMatchSkills registration or the orientation process prior to the stated deadline of October 17, 2024. The record shows that claimant received notice of these requirements prior to the deadline, but did not complete them because of personal difficulties she was facing at the time which took priority over these requirements. While the reasons claimant did not complete the requirements before October 17, 2024, are understandable, the applicable rules do not contain any "good cause" exceptions, such as for emergencies in one's personal life. Therefore, because claimant did not register for work in accordance with the Department's rules, she was not eligible for benefits for the weeks at issue.

**DECISION:** Order No. 24-UI-274043 is affirmed.
