# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0845-R

EAB Decision 2024-EAB-0845 Vacated Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 26, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the week of September 15, 2024 through September 21, 2024 (week 38-24) and was therefore ineligible to receive unemployment insurance benefits for that week (decision # L0006413384). On October 16, 2024, decision # L0006413384 became final without claimant having filed a request for hearing. On November 9, 2024, claimant filed a late request for hearing. ALJ Kangas considered the request, and on November 27, 2024, issued Order No. 24-UI-275132, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 11, 2024.

On December 11, 2024, claimant filed a timely appellant questionnaire response and application for review of Order No. 24-UI-275132, which were forwarded to the Office of Administrative Hearings (OAH). On December 13, 2024, claimant filed an additional application for review of Order No. 24-UI-275132 with the Employment Appeals Board (EAB). On January 3, 2025, OAH mailed a letter to claimant stating that Order No. 24-UI-275132 was vacated and that a hearing would be scheduled to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # L0006413384. On January 14, 2025, EAB issued EAB Decision 2024-EAB-0845, affirming Order No. 24-UI-275132. On February 24, 2025, OAH notified EAB that a hearing was pending in the matter.

EAB erred by issuing the decision in this matter after OAH had vacated Order No. 24-UI-275132. This decision is therefore issued pursuant to EAB's authority under ORS 657.290(3) to reconsider any previous decision of EAB upon its own motion.

**CONCLUSIONS AND REASONS:** EAB Decision 2024-EAB-0845 is vacated and this matter remanded to OAH for a determination of whether claimant's late request for hearing should be allowed and, if so, the merits of decision # L0006413384.

ORS 657.290(3) authorizes the Employment Appeals Board, upon its own motion, to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the

extent necessary and appropriate for the correction of previous error of fact or law." OAR 471-041-0145(1) (May 13, 2019).

On January 14, 2025, EAB issued EAB Decision 2024-EAB-0845, affirming Order No. 24-UI-275132. EAB issued this decision in response to claimant's December 13, 2024 application for review. However, claimant had filed a timely appellant questionnaire response and application for review on December 11, 2024, which OAH had not processed when EAB began its review based on the December 13, 2024 application. OAH subsequently vacated Order No. 24-UI-275132, and a hearing in the matter is currently pending. EAB therefore lacked jurisdiction to issue EAB Decision 2024-EAB-0845. Accordingly, EAB Decision 2024-EAB-0845 is vacated, and this matter is remanded for a hearing to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # L0006413384.

**DECISION:** EAB Decision 2024-EAB-0845 is vacated and this matter remanded to OAH for further proceedings consistent with this decision.
