EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0856

Affirmed
Late Requests for Hearing Dismissed

PROCEDURAL HISTORY: On September 10, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the week of August 25, 2024, through August 31, 2024 (week 35-24) and was therefore ineligible to receive benefits for that week (decision # L0005998268). On September 13, 2024, the Department served notice of an administrative decision concluding that claimant did not actively seek work during the week of July 14, 2024, through July 20, 2024 (week 29-24) and was therefore ineligible to receive benefits for that week (decision # L0006120329). On September 30, 2024, and October 3, 2024, decisions # L0005998268 and L0006120329, respectively, became final without claimant having filed a request for hearing. On October 29, 2024, claimant filed a late request for hearing on each decision. ALJ Kangas considered the requests, and on November 25, 2024, issued Orders No. 24-UI-274638 and 24-UI-274635, dismissing claimant's requests for hearing on decisions # L0005998268 and L0006120329, respectively, as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by December 9, 2024. On December 12, 2024, claimant filed applications for review of Orders No. 24-UI-274638 and 24-UI-274635 with the Employment Appeals Board (EAB). \(^1\)

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 24-UI-274638 and 24-UI-274635. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2024-EAB-0856 and 2024-EAB-0857).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's appellant questionnaire response, has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to

¹ The applications for review were filed by mail but did not contain a postmark. EAB received them on Monday, December 16, 2024, and determined the most probable date of filing to be Thursday, December 12, 2024. *See* OAR 471-041-0065 (May 13, 2019).

EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Decision # L0005998268, mailed to claimant's address of record on September 10, 2024, stated, "You have the right to appeal our decision and request a hearing if you believe our decision is wrong. We must receive your request for a hearing no later than **September 30, 2024**." Order No. 24-UI-274638, Exhibit 1 at 1 (emphasis in original). Decision # L0005998268 also explained how to file the request for hearing, including by using Frances Online, mail, or telephone. Order No. 24-UI-274638, Exhibit 1 at 2.

- (2) Decision # L0006120329, mailed to claimant's address of record on September 13, 2024, stated, "You have the right to appeal our decision and request a hearing if you believe our decision is wrong. We must receive your request for a hearing no later than **October 3, 2024**." Order No. 24-UI-274635, Exhibit 1 at 1 (emphasis in original). Decision # L0006120329 also explained how to file the request for hearing, including by using Frances Online, mail, or telephone. Order No. 24-UI-274635, Exhibit 1 at 2.
- (3) Claimant received each decision shortly after it was mailed. Claimant filed late a request for hearing on each decision on October 29, 2024.

CONCLUSIONS AND REASONS: Claimant's late requests for hearing are dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The requests for hearing on decisions # L0005998268 and L0006120329 were due by September 30, 2024, and October 3, 2024, respectively. Claimant's requests for hearing were filed on October 29, 2024, and were therefore late.

Claimant wrote in their appellant questionnaire response that they "tried to meet the deadline, but didn't understand how to, and [weren't] getting the correct advice on how to." EAB Exhibit 1 at 3. The record does not show why claimant could not have followed the instructions in each administrative decision for filing a request for hearing. It also does not show why, if claimant desired further explanations regarding the decisions or the appeals process, they could not have been obtained it prior to the filing deadlines. Therefore, claimant has not shown that they were prevented from filing timely requests for hearing by factors beyond their reasonable control.

Although the delay in filing to seek additional information about the administrative decisions or appeal process was likely the result of a mistake on claimant's part, it was not an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Accordingly, good cause does not exist to extend the filing deadlines, and claimant's late requests for hearing are dismissed.

DECISION: Orders No. 24-UI-274638 and 24-UI-274635 are affirmed.
