Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 17, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective July 28, 2024, decision # L0006352799). Claimant filed a timely request for hearing. On October 23, 2024, notice was mailed to the parties that a hearing was scheduled for November 8, 2024. On November 8, 2024, claimant failed to appear for the hearing, and on November 12, 2024, ALJ Griffith issued Order No. 24-UI-272900, dismissing the request for hearing due to claimant's failure to appear. On November 20, 2024, claimant filed an application for review of Order No. 24-UI-272900 that was treated as a request to reopen the hearing. ALJ Kangas considered the request, and on December 12, 2024, issued Order No. 24-UI-276497, dismissing the request to reopen, subject to claimant's right to renew the request by providing information about why they failed to appear at the hearing by December 26, 2024. On December 24, 2024, claimant filed an application for review of Order No. 24-UI-276497 with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's request to reopen is denied.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's reasonable control. OAR 471-040-0040(2) (February 10, 2012). The party requesting reopening shall set forth the reason(s) for missing the hearing in a written statement, which the Office of Administrative

¹ Decision # L0006352799 stated that claimant was denied benefits from August 25, 2024 to August 23, 2025. However, decision # L0006352799 alleged that the work separation occurred on August 1, 2024 and therefore should have stated that claimant was disqualified from receiving benefits beginning Sunday, July 28, 2024 and until they earned four times their weekly benefit amount. *See* ORS 657.176.

² OAR 471-041-0060(4) (May 13, 2019) provides, "Except as otherwise stated in this rule, EAB will treat an application for review by a claimant or employer that failed to appear at a hearing as a request to reopen the hearing under ORS 657.270."

Hearings (OAH) shall consider in determining whether good cause exists for failing to appear at the hearing. OAR 471-040-0040(3).

Claimant failed to appear at the November 8, 2024, hearing. On November 20, 2024, claimant filed a timely application for review of Order No. 24-UI-272900, which dismissed claimant's request for hearing due to their failure to appear. Pursuant to OAR 471-041-0060(4), that application for review was treated as a request to reopen the hearing. However, claimant provided no explanation for missing the hearing in that filing. Additionally, Order No. 24-UI-276497, which denied the request to reopen, gave claimant until December 26, 2024, to provide an explanation for missing the hearing, in which case the request to reopen would be reconsidered. Claimant did not provide information to OAH or EAB explaining the reason they missed the hearing. Accordingly, good cause has not been shown to reopen the November 8, 2024, hearing, and the request to reopen is denied.

DECISION: Order No. 24-UI-276497 is affirmed.
