# EMPLOYMENT APPEALS BOARD DECISION 2024-EAB-0872

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 3, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct, and therefore was disqualified from receiving unemployment insurance benefits effective November 5, 2023 (decision # 144240). Claimant filed a timely request for hearing. On January 24, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 7, 2024. On February 7, 2024, claimant failed to appear at the hearing, and ALJ Smith issued Order No. 24-UI-247500, dismissing claimant's request for hearing due to his failure to appear. On February 13, 2024, claimant filed a timely request to reopen the hearing.

On March 4, 2024, ALJ L. Lee conducted a hearing, and on March 13, 2024 issued Order No. 24-UI-249961, allowing claimant's request to reopen the hearing, canceling Order No. 24-UI-247500, and affirming decision # 144240 on the merits. On April 2, 2024, Order No. 24-UI-249961 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 30, 2024, claimant filed a late application for review of Order No. 24-UI-249961 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with his application for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must send the objection to EAB in writing, explaining the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** The application for review is dismissed without prejudice.

On December 30, 2024, claimant filed an application for review of Order No. 24-UI-249961 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 2, 2024. Claimant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time if the applicant can show they have good cause to extend the deadline. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If claimant believes he has good cause and filed his late application for review within a reasonable time, claimant may ask EAB to reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

- 1. Claimant must file the request for reconsideration by February 13, 2025, and
- 2. Claimant must state in the request for reconsideration that he sent a copy of the request to the other party (American Heating Inc.), *and*
- 3. Claimant must provide additional specific details about the reason he filed a late application for review. For example, claimant should include specific information about the date he received the ALJ's Order No. 24-UI-249961, whether he read and disagreed with it, and how he was prevented from filing his application for review by April 2, 2024. Claimant should include specific details that might help EAB determine whether or not claimant had "good cause," which means factors or circumstances beyond his reasonable control prevented him from filing a timely application for review, such as the serious illness he referenced in his application for review, and
- 4. Claimant must provide the date the circumstances that prevented him from filing a timely application for review ended (the circumstances he listed in response to #3), and
- 5. Claimant must provide sufficient information to prove that he filed his application for review within **seven** days of the date the circumstances that prevented him from filing a timely application for review ended.

There are several ways to file a request for reconsideration:

Please note that you need only file *one* request for reconsideration.

**DECISION:** The application for review filed December 30, 2024 is dismissed without prejudice. Order No. 24-UI-249961 remains undisturbed.
