EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0003

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 25, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective September 29, 2024 (decision # L0006836748). Claimant filed a timely request for hearing. On or around November 21, 2024, claimant contacted the Office of Administrative Hearings (OAH) and requested to withdraw their request for hearing on decision # L0006836748. On November 21, 2024, ALJ Lucas issued Order No. 24-UI-274188, allowing claimant's request to withdraw their appeal and dismissing claimant's request for hearing on decision # L0006836748. On December 11, 2024, Order No. 24-UI-274188 became final without claimant having filed an application for review with the Employment Appeals Board (EAB).

On December 30, 2024, claimant emailed OAH advising that they had filed a second appeal of decision # L0006836748 and received a message from a Department representative via Frances Online that the appeal had not yet been sent to OAH, and inquiring about the status of the second appeal. EAB has construed claimant's December 30, 2024, email to OAH as late application for review of Order No. 24-UI-274188.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's December 30, 2024, email to OAH, which EAB has construed as an application for review of Order No. 24-UI-274188 and that contains information EAB has construed as a written statement accompanying claimant's application for review. The email has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

¹ Decision # L0006836748 stated that claimant was denied benefits from October 6, 2024, to October 4, 2025. However, because decision # L0006836748 found that claimant's work separation occurred on October 2, 2024, the decision should have stated that claimant was disqualified from receiving benefits beginning Sunday, September 29, 2024, and until claimant earned four times their weekly benefit amount. *See* ORS 657.176.

FINDINGS OF FACT: (1) Order No. 24-UI-274188, mailed to claimant on November 21, 2024, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 24-UI-274188 at 1. Order No. 24-UI-274188 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before December 11, 2024, to be timely."

(2) On December 30, 2024, claimant filed a late application for review of Order No. 24-UI-274188 with EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 24-UI-274188 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 24-UI-274188 was due by December 11, 2024. Because claimant did not file their application for review until December 30, 2024, the application for review was late. Claimant provided a written statement with the application for review. *See* EAB Exhibit 1 at 1. However, claimant's written statement did not describe circumstances preventing claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and the late application for review is dismissed.

A review of claimant's written statement suggests that claimant filed a second request for hearing on decision # L0006836748 at some point before December 19, 2024, and that on December 19, 2024, a Department representative informed claimant that the request for hearing had not yet been sent to OAH. EAB Exhibit 1 at 1. Claimant may wish to contact the Department to inquire whether the Department has sent claimant's second request for hearing to OAH. Claimant also may wish to contact OAH again to check whether the second hearing request has been received.

DECISION: The application for review filed December 31, 2024 is dismissed. Order No. 24-UI-274188 remains undisturbed.
