# EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0071

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On November 8, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective June 30, 2024 (decision # L0007107333).<sup>1</sup> Claimant filed a timely request for hearing. On January 2, 2025, ALJ Allen conducted a hearing, and on January 8, 2025 issued Order No. 25-UI-279196, modifying decision # L0007107333 by concluding that claimant was disqualified from receiving benefits, effective June 23, 2024.<sup>2</sup> On January 28, 2025, Order No. 25-UI-279196 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 30, 2025, claimant filed a late application for review of Order No. 25-UI-279196 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written statement submitted with her Application for Review. The written statement has been marked as EAB Exhibit 1 and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**FINDING OF FACT:** Order No. 25-UI-279196, mailed to claimant on January 8, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-279196 at 5.

<sup>&</sup>lt;sup>2</sup> Although Order No. 25-UI-279196 stated that it affirmed decision # L0007107333, it actually modified decision # L0007107333 by changing the beginning date of the disqualification from June 30, 2024 to June 23, 2024.

Order No. 25-UI-279196 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 28, 2025 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 25-UI-279196 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-279196 was due January 28, 2025. Because claimant did not file their application for review until January 30, 2025, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed January 30, 2025 is dismissed. Order No. 25-UI-279196 remains undisturbed.
