# EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0084

Late Applications for Review Dismissed

**PROCEDURAL HISTORY:** On September 19, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from February 25 through March 16, 2024 (weeks 9-24 through 11-24) and was denied benefits for those weeks (decision # L0006287976). Also on September 19, 2024, the Department served notice of an administrative decision denying claimant's request to backdate her restart claim to March 17, 2024 (decision # L0006240202). On October 3, 2024, the Department served notice of an administrative decision denying claimant's request to backdate her restart claim to March 24, 2024 (decision # L0006388933). Claimant filed timely requests for hearing on all three administrative decisions.

On January 16, 2025, ALJ Scott conducted a hearing and issued Orders No. 25-UI-280098, 25-UI-280097, and 25-UI-280095 affirming decisions # L0006287976, L0006240202, and L0006388933. On February 5, Orders No. 25-UI-280098, 25-UI-280097, 25-UI-280095 became final without claimant having filed applications for review with the Employment Appeals Board (EAB). On February 6, 2025, claimant filed late applications for review of Orders No. 25-UI-280098, 25-UI-280097, and 25-UI-280095 with EAB.

EAB combined its review of Orders No. 25-UI-280098, 25-UI-280097 and 25-UI-280095 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2025-EAB-0084, 2025-EAB-0083, and 2025-EAB-0082).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's application for review dated February 6, 2025, which has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record

FINDING OF FACT: Orders No. 25-UI-280098, 25-UI-280097, 25-UI-280095 mailed to claimant on January 16, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-280098 at 3, Order No. 25-UI-280097 at 4, and Order No. 25-UI-280095 at 4. Orders No. 25-UI-280098, 25-UI-280097, and 25-UI-280095 also stated on their Certificates of Mailing, "Any appeal from this Order must be filed on or before February 5, 2025 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late applications for review of Orders No. 25-UI-280098, 25-UI-280097, and 25-UI-280095 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Orders No. 25-UI-280098, 25-UI-280097, and 25-UI-280095 were due February 5, 2025. Because claimant did not file their applications for review until February 6, 2025, the applications for review were late. EAB Exhibit 1. Claimant's applications for review did not include a written statement describing the circumstances that prevented her from filing the applications for review by the February 5, 2025 deadline. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

**DECISION:** The applications for review filed February 6, 2025 are dismissed. Orders No. 25-UI-280098, 25-UI-280097, and 25-UI-280095 remain undisturbed.
