## EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0129

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On December 3, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer with good cause and was not disqualified from receiving benefits based on the work separation (decision # L0007539740). The employer filed a timely request for hearing. On January 27, 2025, ALJ Lucas conducted a hearing, and on January 30, 2025, issued Order No. 25-UI-281578, affirming decision # L0007539740. On February 19, 2025, Order No. 25-UI-281578 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On February 27, 2025, the employer filed a late application for review of Order No. 25-UI-281578 with EAB.

**FINDING OF FACT:** Order No. 25-UI-281578, mailed to claimant on January 30, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-281578 at 4. Order No. 25-UI-281578 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 19, 2025, to be timely."

**CONCLUSIONS AND REASONS:** The employer's late application for review of Order No. 25-UI-281578 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-281578 was due February 19, 2025. Because the employer did not file their application for review until February 27, 2025, the application for review was late. The employer's application for review did not include a written statement describing circumstances preventing them from filing the application for review by the February 19, 2025, deadline. Accordingly, the employer did not show good cause for the late application for review, and their late application for review is dismissed.

**DECISION:** The application for review filed February 27, 2025 is dismissed. Order No. 25-UI-281578 remains undisturbed.
