EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0132

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 12, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits from October 20, 2024, to October 18, 2025 (decision # L0007126846).¹ Claimant filed a timely request for hearing. On January 29, 2025, ALJ Frank conducted a hearing, and on February 6, 2025, issued Order No. 25-UI-282289, modifying decision # L0007126846 by concluding claimant quit work without good cause and was disqualified from receiving benefits effective October 13, 2024.² On February 26, 2025, Order No. 25-UI-282289 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 28, 2025, claimant filed a late application for review of Order No. 25-UI-282289 with EAB.

FINDING OF FACT: Order No. 25-UI-282289, mailed to claimant on February 6, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-282289 at 3. Order No. 25-UI-282289 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 26, 2025, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-282289 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-282289 was due February 26, 2025. Because claimant did not file their application for review until February 28, 2025, the application for review was late. Claimant's application for review did not include a written statement describing circumstances preventing claimant from filing the application for review by the February 26, 2025, deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed February 28, 2025 is dismissed. Order No. 25-UI-282289 remains undisturbed.
