EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0137-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On December 20, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer with good cause and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # L0007863241). The employer filed a timely request for hearing. On February 20, 2025, ALJ Griffith conducted a hearing, and on February 27, 2025, issued Order No. 25-UI-284435, reversing decision # L0007918513 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective January 21, 2024. On March 4, 2025, claimant filed an application for review with the Employment Appeals Board (EAB). On April 2, 2025, EAB issued 2025-EAB-0137, affirming Order No. 25-UI-284435. On May 6, 2025, claimant filed a request for reconsideration with EAB.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is dismissed. EAB Decision 2025-EAB-0137 remains undisturbed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

On April 2, 2025, EAB issued EAB Decision 2025-EAB-0137. Claimant did not file her request for reconsideration with EAB until May 6, 2025. Accordingly, claimant's request for reconsideration was filed more than 20 days after the decision was mailed and is late. OAR 471-041-0145(2) contains no exception to the requirements that a request for reconsideration must be filed on or before the 20th day

after the decision sought to be reconsidered was mailed. For these reasons, claimant's request for reconsideration is dismissed.

DECISION: Claimant's request for reconsideration is dismissed. EAB decision 2025-EAB-0137 remains undisturbed. Order No. 25-UI-284435 remains undisturbed.
