EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0148

Moot Application for Review Dismissed

PROCEDURAL HISTORY: On December 24, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to verify his identification as required by the Department's rules, and therefore was ineligible to receive unemployment insurance benefits effective December 15, 2024 (decision # L0007910729). Claimant filed a timely request for hearing. On February 19, 2025, ALJ Enyinnaya conducted a hearing at which the Department failed to appear, and on February 27, 2025 issued Order No. 25-UI-284459, modifying decision # L0007910729 by concluding that claimant failed to verify his identity as required by the Department's rules, and therefore was ineligible to receive benefits for the weeks of December 15, 2024 through February 15, 2025 (weeks 51-24 through 07-25).¹ On March 3, 2025, claimant filed an application for review with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) On December 24, 2024, the Department issued decision # L0007910729, concluding that claimant failed to verify his identity and therefore was ineligible for benefits effective December 15, 2024.

(2) On February 27, 2025, after a hearing on the matter, ALJ Enyinnaya issued Order No. 25-UI-284459, modifying decision # L0007910729 by concluding that claimant was ineligible for benefits for weeks 51-24 through 07-25, the weeks at issue. At that time the Department had not paid claimant benefits for any of the weeks at issue.

(3) On March 3, 2025, the Department entered a comment into claimant's claim records that stated, "Due to management directive, we are reversing identity Verification (IDV)/FTP denials to allow payments for the weeks at issue." On the same day, the Department paid claimant benefits for all of the weeks at issue.²

(4) Also on March 3, 2025, claimant filed his application for review of Order No. 25-UI-284459.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 25-UI-284459 presents no justiciable controversy and is dismissed.

On or around the same day that claimant filed his timely application for review of Order No. 25-UI-284459, the Department cancelled decision # L0007910729 and paid claimant benefits for the weeks at issue. Oregon courts follow the principle that a review on appeal may only be provided for justiciable controversies. See, e.g., *Gortmaker v. Seaton*, 252 Or. 440, 442, 450 P.2d 547 (1969). A justiciable controversy exists when the interests of the parties to the action conflict with each other, and the appeal will have some practical effect on the rights of the parties to the controversy. *Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). To show a practical effect on their rights, an appellant must seek "substantive relief" through their appeal. *Krisor v. Henry*, 256 Or. App. 56, 300 P.3d 199 (Or. Ct. App. 2013). Because decision # L0007910729 and the period of ineligibility it imposed are no longer in effect, claimant's application for review of the order under review presents no justiciable controversy, and is subject to dismissal as moot.

Because EAB's review of this matter could not provide substantive relief to the appellant, such review would have no practical effect on the appellant's rights. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. Because the case before EAB presents no justiciable controversy, the application for review of Order No. 25-UI-284459 is dismissed and Order No. 25-UI-284459 remains undisturbed.

DECISION: Claimant's March 3, 2025, application for review is dismissed as moot. Order No. 25-UI-284459 remains undisturbed.
