EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0150

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 15, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits from October 27, 2024 to October 25, 2025 (decision # L0007367718). Claimant filed a timely request for hearing. On December 10, 2024, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 24, 2024. On December 24, 2024, claimant failed to appear at the hearing, and ALJ Parnell issued Order No. 24-UI-277927, dismissing claimant's request for hearing for failing to appear. On December 24, 2024, claimant filed a timely request to reopen the hearing.

On January 30, 2025, ALJ Parnell conducted a hearing, and on February 4, 2025, issued Order No. 25-UI-281955, allowing claimant's request to reopen the December 24, 2024, hearing and modifying decision # L0007367718 by concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective October 6, 2024. On February 24, 2025, Order No. 25-UI-281955 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 7, 2025, claimant filed a late application for review of Order No. 25-UI-281955 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's application for review and an attached message to claimant from a union representative, and has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within

ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit(s) will remain in the record.

FINDING OF FACT: Order No. 25-UI-281955, mailed to claimant on February 4, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-281955 at 6. Order No. 25-UI-281955 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 24, 2025, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-281955 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-281955 was due February 24, 2025. Because claimant did not file their application for review until March 7, 2025, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe circumstances preventing claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed March 7, 2025 is dismissed. Order No. 25-UI-281955 remains undisturbed.
