EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0151

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 22, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from November 10 through 16, 2024 (week 46-24) and was ineligible for benefits for that week (decision # L0007302783). Claimant filed a timely request for hearing. On January 13, 2025, ALJ Strauch conducted a hearing, and on January 24, 2025, issued Order No. 25-UI-280994, affirming decision # L0007302783. On February 13, 2025, Order No. 25-UI-280994 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 8, 2025, claimant filed a late application for review of Order No. 25-UI-280994 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's late application for review and written statement, which has been marked as EAB Exhibit 1 and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

FINDING OF FACT: Order No. 25-UI-280994, mailed to claimant on January 24, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-280994 at 4. Order No. 25-UI-280994 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 13, 2025, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-280994 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-280994 was due February 13, 2025. Because claimant did not file his application for review until March 8, 2025, the application for review was late. Claimant provided a written statement with the application for review. Claimant asserted that the circumstances that prevented him from filing the application for review on time were, "I usually work over 50 hours a week in Portland while living in Salem. I was also in the process of buying a house throughout February. I had no time to go through this appeal process until now." EAB Exhibit 1 at 1. Claimant further asserted that the circumstances preventing him from filing a timely application for review ended on March 8, 2025, the date he filed his late application for review. EAB Exhibit 1 at 1.

Claimant was undoubtedly busy working and commuting, and purchasing a home throughout the month of February. However, his bare assertion that he had no time to go through the appeal process until March 8, 2025, is not enough to show that working and commuting, and the process of purchasing a home prevented him from filing his application for review by the February 13, 2025, deadline, and not until 23 days after the deadline, and about 8 days after he finished the process of purchasing a house. Claimant therefore failed to establish good cause to extend the filing period to March 8, 2025, and his late application for review therefore is dismissed.

DECISION: The application for review filed March 8, 2025 is dismissed. Order No. 25-UI-280994 remains undisturbed.
