EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0153

Application for Review Dismissed

PROCEDURAL HISTORY: On May 5, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$13,424 overpayment that claimant was required to repay, a \$4,027.20 monetary penalty, and a 52-week penalty disqualification from future benefits (decision # 193509). On May 25, 2023, decision # 193509 became final without claimant having filed a request for hearing. On December 3, 2024, claimant filed a late request for hearing. ALJ Scott considered the request, and on January 28, 2025, issued Order No. 25-UI-281346, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 11, 2025. On February 5, 2025, claimant filed a timely response to the appellant questionnaire and an application for review with the Employment Appeals Board (EAB), which the Office of Administrative Hearings (OAH) did not process until March 12, 2025. On February 18, 2025, Order No. 25-UI-281346 appeared to become final without an appellant questionnaire response or application for review having been processed by OAH or received by EAB.

On March 10, 2025, claimant filed a late application for review of Order No. 25-UI-281346 with EAB, believing that the February 5, 2025, submission had been lost and would not be considered filed. On March 12, 2025, OAH processed the February 5, 2025, filing and mailed a letter to the parties stating that Order No. 25-UI-281346 was vacated and that a hearing would be scheduled to determine whether claimant's late request for hearing on decision # 193509 should be allowed and, if so, the merits of that decision. This matter comes before EAB based on claimant's March 10, 2025, late application for review of Order No. 25-UI-281346.

FINDING OF FACT: On March 15, 2025, claimant emailed EAB asking to withdraw his March 10, 2025, late application for review of Order No. 25-UI-281346 based on OAH having subsequently vacated that order.

CONCLUSIONS AND REASONS: Claimant's March 10, 2025, late application for review is dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

On March 15, 2025, EAB received a written request, by email, in which claimant withdrew the application for review of Order No. 25-UI-281346. EAB had not yet issued a decision. Under OAR 471-041-0098, claimant's request to withdraw the application for review is allowed.

DECISION: The application for review filed March 10, 2025 is dismissed. This matter remains pending at OAH.
