EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0210

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 15, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was therefore disqualified from receiving unemployment insurance benefits effective October 20, 2024 (decision # L0008719793). On February 4, 2025, decision # L0008719793 became final without claimant having filed a request for hearing. On February 25, 2025, claimant filed a late request for hearing on decision # L0008719793.

ALJ Kangas considered claimant's request, and on March 12, 2025 issued Order No. 25-UI-285763, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 26, 2025. On April 1, 2025, Order No. 25-UI-285763 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On April 6, 2025, claimant filed a late application for review of Order No. 25-UI-285763 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with their application for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must send the objection to EAB in writing, explaining the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

¹ Decision # L0008719793 stated that claimant was denied benefits from October 20, 2024, to December 13, 2025. However, decision # L0008719793 should have said that claimant was disqualified from receiving benefits beginning Sunday, October 20, 2024, and until she earned four times their weekly benefit amount. *See* ORS 657.176.

On April 6, 2025, claimant filed an application for review of Order No. 25-UI-285763 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than April 1, 2025. Claimant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time if the applicant can show they have good cause to extend the deadline. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If claimant believes they have good cause and filed their late application for review within a reasonable time, claimant may ask EAB to reconsider this decision under OAR 471-041-0145 (May 13, 2019). Claimant filed a written statement with their application for review. EAB Exhibit 1. The statement describes why claimant filed their request for hearing on decision # L0008719793 late. However, the statement submitted with claimant's application for review did not explain why claimant did not file the application for review of Order No. 25-UI-285763 by the April 1, 2025 deadline.

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. Claimant must file the request for reconsideration with EAB by May 19, 2025, and
- 2. Claimant must state in the request for reconsideration that they sent a copy of the request to the other party, *and*
- 3. Claimant must provide additional specific details about the reason they filed a late application for review of Order No. 25-UI-285763 to EAB. For example, claimant should include specific information about the date they received the ALJ's Order No. 25-UI-285763, whether they read it, and how they were prevented from filing their application for review by April 1, 2025. Please note, claimant must provide details on why they filed the late application for review on April 1, 2025 and not why they filed a late request for hearing on decision # L0008719793 issued February 25, 2025. Claimant should include specific details that might help EAB determine whether or not claimant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. Claimant must provide the date the circumstances that prevented them from filing a timely application for review ended (the circumstances they listed in response to #3, above), *and*
- 5. Claimant must provide sufficient information to prove that they filed their application for review within **seven** days of the date the circumstances that prevented them from filing a timely application for review ended.

There are several ways to file a request for reconsideration:

Please note that you need only file *one* request for reconsideration.

DECISION: The application for review filed April 6, 2025 is dismissed without prejudice. Order No. 25-UI-285763 remains undisturbed.
