

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0214

Affirmed
No Disqualification

PROCEDURAL HISTORY: On January 14, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant was disqualified from receiving unemployment insurance benefits effective December 15, 2024 (decision # L0008449560).¹ Claimant filed a timely request for hearing. On March 28, 2025,² ALJ Murdock conducted a hearing, and on April 3, 2025 issued Order No. 25-UI-288322, reversing decision # L0008449560 by concluding that claimant was discharged, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. On April 7, 2025, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-288322's findings of fact, reasoning, and conclusion that claimant was discharged, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. Order No. 25-UI-288322 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-288322 is affirmed.

¹ Decision # L0008449560 stated that claimant was denied benefits from December 15, 2024 to December 13, 2025. However, decision # L0008449560 should have stated that claimant was disqualified from receiving benefits beginning Sunday, December 15, 2024 and until she earned four times her weekly benefit amount. See ORS 657.176.

² Order No. 25-UI-288322 stated in the History of the Case that a hearing was held on February 18, 2025. This is presumed a scrivener's error because the hearing was held on March 28, 2025.
