EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0217

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 14, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause and was disqualified from receiving benefits effective December 15, 2024 (decision # L0008578734). Claimant filed a timely request for hearing. On March 12, 2025, ALJ Enyinnaya conducted a hearing at which the employer did not appear, and on March 18, 2025, issued Order No. 25-UI-286450, modifying decision # L0008578734 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective December 8, 2024, until requalified under Department law. On April 7, 2025, Order No. 25-UI-286450 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 8, 2025, claimant filed a late application for review of Order No. 25-UI-286450 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's Application for Review, has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

FINDING OF FACT: Order No. 25-UI-286450, mailed to claimant on March 18, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-286450 at 3.

¹ Decision # L0008578734 stated that claimant was denied benefits from December 15, 2024, to October 11, 2025. However, because decision # L0008578734 found that claimant quit on December 14, 2024, it should have stated that claimant was disqualified from receiving benefits beginning Sunday, December 8, 2024, and until she earned four times her weekly benefit amount. *See* ORS 657.176.

² Although Order No. 25-UI-286450 stated it affirmed decision # L0008578734, it modified decision # L0008578734 by changing the disqualification period from December 15, 2024, to October 11, 2025, to December 8, 2024 until claimant requalified under Department law. Order No. 25-UI-286450 at 3.

Order No. 25-UI-286450 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 7, 2025, to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-286450 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-286450 was due April 7, 2025. Because claimant did not file their application for review until April 8, 2025, the application for review was late. EAB Exhibit 1. Claimant's application for review did not include a written statement describing circumstances preventing claimant from filing the application for review by the April 7, 2025, deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed April 8, 2025 is dismissed. Order No. 25-UI-286450 remains undisturbed.
