EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0223

Affirmed No Disqualification

PROCEDURAL HISTORY: On February 27, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective February 2, 2025 (decision # L0009473656).¹ Claimant filed a timely request for hearing. On April 3, 2025, ALJ Murdock conducted a hearing, and on April 9, 2025, issued Order No. 25-UI-288962, reversing decision # L0009473656 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On April 14, 2025, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Claimant asserted that he did not submit the new information, a series of photographs, prior to hearing because, "I could not find any place on [Frances Online] that would allow me to upload it." Claimant's Argument at 1. However, the Notice of Hearing stated, "If you have other documents that you wish to have considered, you must provide copies of your documents to all parties and to the ALJ at the Office of Administrative Hearings *at their address as listed on the Certificate of Mailing* prior to the date of the scheduled hearing." Notice of Hearing at 1 (emphasis added). Claimant's failure to follow these instructions did not constitute a factor or circumstance beyond his reasonable control that prevented timely submission of the photographs. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing. EAB considered any parts of claimant's argument that were based on the hearing record.

¹ Decision # L0009473656 stated that claimant was denied benefits from February 2, 2025, to January 31, 2026. However, decision # L0009473656 should have stated that claimant was disqualified from receiving benefits beginning Sunday, February 2, 2025, and until he earned four times his weekly benefit amount. *See* ORS 657.176.

EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-288962's findings of fact, reasoning, and conclusion that claimant was discharged, but not for misconduct. Order No. 25-UI-288962 is **adopted**. *See* ORS 657.275(2).

DECISION: Order No. 25-UI-288962 is affirmed.
