# EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0259-R-R

Request for Reconsideration Denied

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 31, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective October 13, 2024 (decision # L0006932335). Claimant filed a timely request for hearing. On January 27, 2025, and continuing on March 3 and April 11, 2025, ALJ Lucas conducted a hearing, and on April 11, 2025, issued Order No. 25-UI-289269, affirming decision # L0006932335 by concluding that claimant was discharged for misconduct and therefore disqualified from receiving benefits effective October 13, 2024.

On April 28, 2025, claimant filed an application for review with the Employment Appeals Board (EAB). On June 4, 2025, EAB issued EAB Decision 2025-EAB-0259, affirming Order No. 25-UI-289269. On June 23, 2025, claimant filed a timely request for reconsideration of EAB Decision 2025-EAB-0259. On July 29, 2025, EAB issued EAB Decision 2025-EAB-0259-R, allowing claimant's request for consideration and adhering to EAB Decision 2025-EAB-0259. On August 15, 2025, claimant filed a request for reconsideration of EAB Decision 2025-EAB-0259-R with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**EVIDENTIARY MATTER:** Claimant's August 15, 2025 request for reconsideration contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing.

However, decision # L0006932335 should have stated that claimant was disqualified from receiving benefits beginning Sunday, October 13, 2024 and until she earned four times her weekly benefit amount. *See* ORS 657.176.

**CONCLUSIONS AND REASONS:** Claimant's request for reconsideration of EAB Decision 2025-EAB-0259-R is denied.

ORS 657.290(3) permits the Employment Appeals Board, in its discretion, to reconsider any past decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request will be dismissed unless it says that a copy of the request was given to the other parties, and unless it is filed within 20 days after the decision the party wants to be reconsidered was mailed. OAR 471-041-0145(2).

Claimant's August 15, 2025 request for reconsideration was filed within 20 days of the date EAB Decision 2025-EAB-0259-R was mailed, and stated that a copy of it was mailed to the employer. The request for reconsideration is therefore not subject to dismissal under OAR 471-041-0145(2).

However, the August 15, 2025 request for reconsideration asserted the same errors of fact or law that were addressed in EAB Decision 2025-EAB-0259-R, which allowed claimant's June 23, 2025 request for reconsideration of EAB Decision 2025-EAB-0259, and adhered to that decision on reconsideration. Further reconsideration of those alleged errors would not yield a different result. Claimant's disagreement with the findings of fact or conclusions of law in EAB Decision 2025-EAB-0259-R are therefore best addressed through appeal to the Court of Appeals, and information about claimant's appellate rights is noted below. Accordingly, claimant's request to reconsider EAB Decision 2025-EAB-0259-R is denied.

**DECISION:** Claimant's request for reconsideration of EAB Decision 2025-EAB-0259-R is denied. EAB Decision 2025-EAB-0259-R remains undisturbed.
