EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0291-R

Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 19, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective December 1, 2024 (decision # L0007761815). Claimant filed a timely request for hearing. On February 13, 2025, ALJ Enyinnaya conducted a hearing, and on February 20, 2025, issued Order No. 25-UI-283606, concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On March 12, 2025, Order No. 25-UI-283606 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On May 14, 2025, the employer filed a late application for review with EAB. On June 3, 2025, EAB issued EAB Decision 2025-EAB-0291, dismissing the employer's late application for review without prejudice. On June 18, 2025, the employer filed a timely request for reconsideration of EAB Decision 2025-EAB-0291. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the employer's request for reconsideration, has been marked as EAB Exhibit 2, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: The employer's request for reconsideration is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2) (May 13, 2019).

EAB dismissed the employer's late application for review without prejudice and subject to the employer filing a timely request for reconsideration in accordance with the requirements of OAR 471-041-0145(2). While the request for reconsideration was filed within 20 days after the issuance of EAB Decision 2025-EAB-0291 and was therefore timely, it did not contain a statement that a copy was provided to claimant as required by the rule. *See* EAB Exhibit 2. Accordingly, the employer's request for reconsideration of EAB Decision 2025-EAB-0291 is dismissed, and that decision remains undisturbed.

DECISION: The request for reconsideration filed June 18, 2025, is dismissed. EAB Decision 2025-EAB-0291 remains undisturbed.
