# EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0356-R

Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 25, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was suspended for a disqualifying act, and therefore was disqualified from receiving unemployment insurance benefits effective February 23, 2025, through May 31, 2025 (decision # L0009940098). On April 14, 2025, decision # L0009940098 became final without claimant having filed a request for hearing. On April 25, 2025, claimant filed a late request for hearing on decision # L0009940098. ALJ Kangas considered claimant's request, and on May 13, 2025, issued Order No. 25-UI-292129, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 27, 2025. On June 2, 2025, Order No. 25-UI-292129 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On June 10, 2025, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 25-UI-292129 with EAB. On June 27, 2025, EAB issued EAB Decision 2025-EAB-0356, dismissing claimant's late application for review without prejudice. On July 16, 2025, claimant filed a request for reconsideration of EAB Decision 2025-EAB-0356 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** Claimant's request for reconsideration is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20<sup>th</sup> day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB dismissed claimant's late application for review without prejudice and subject to claimant filing a timely request for reconsideration within 20 days after EAB's dismissal decision was issued. Claimant filed their request for reconsideration on July 16, 2025, and therefore within 20 days after EAB's dismissal decision was issued. However, claimant did not include a statement on the request for reconsideration that a copy of the request was provided to the other party (the employer). For this reason, claimant's request for consideration did not meet the requirements set forth in OAR 471-041-0145, and is dismissed.

**DECISION:** Claimant's request for reconsideration is dismissed. EAB Decision 2025-EAB-0356 remains undisturbed.
