

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0364

Affirmed
No Disqualification

PROCEDURAL HISTORY: On April 11, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged, but not for a disqualifying act under the Department's drug, alcohol, and cannabis adjudication policy, and therefore was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # L0010337410). The employer filed a timely request for hearing. On June 5, 2025, ALJ Chiller conducted a hearing at which claimant failed to appear, and on June 10, 2025, issued Order No. 25-UI-294558, affirming decision # L0010337410. On June 13, 2025, the employer filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-294558's findings of fact, reasoning, and conclusion that claimant was discharged, but not for a disqualifying act. Order No. 25-UI-294558 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-294558 is affirmed.
