# EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0377

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On March 25, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to verify his identity in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits effective March 16, 2025, and until the reason for the denial ended (decision # L0009972068). Claimant filed a timely request for hearing. On May 28, 2025, ALJ Scott conducted a hearing at which the Department failed to appear, and on May 29, 2025, issued Order No. 25-UI-293507, modifying decision # L0009972068 by concluding that claimant was ineligible to receive benefits from March 16, 2025 through May 24, 2025 (weeks 12-25 through 21-25). On June 18, 2025, Order No. 25-UI-293507 became final without claimant having filed an application for review of Order No. 25-UI-293507 with the Employment Appeals Board (EAB). On June 19, 2025, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the statement included with claimant's late application for review, has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 25-UI-293507, mailed to claimant on May 29, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-293507 at 5. Order No. 25-UI-293507 also said on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 18, 2025 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 25-UI-293507 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-293507 was due by June 18, 2025. Because claimant did not file his application for review until June 19, 2025, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented him from filing the application for review on time. *See* EAB Exhibit 1 at 1. Accordingly, claimant did not show good cause for the late application for review, and his late application for review is dismissed.

**DECISION:** The application for review filed June 19, 2025 is dismissed. Order No. 25-UI-293507 remains undisturbed.
