EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0404

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 21, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct, and therefore was disqualified from receiving unemployment insurance benefits effective February 23, 2025 through February 21, 2026 (decision # L0010398651). Claimant filed a timely request for hearing. On June 12, 2025, ALJ Rackstraw conducted a hearing, and on June 13, 2025, issued Order No. 25-UI-294960, modifying decision # L0010398651 by concluding that claimant was discharged for misconduct, and was disqualified from receiving benefits effective February 23, 2025 and until requalified under Department law. On July 3, 2025, Order No. 25-UI-294960 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 5, 2025, claimant filed a late application for review of Order No. 25-UI-294960 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's statement enclosed with the application for review, and the postmarked envelope in which the application for review was mailed. This evidence has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 25-UI-294960, mailed to claimant on June 13, 2025, stated, "You may appeal this decision by filing the attached form, Application for Review, with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-294960 at 4. Order No. 25-UI-294960 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 3, 2025 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-294960 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-294960 was due by July 3, 2025. Because claimant did not file her application for review until July 5, 2025, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented her from filing the application for review on time. *See* EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 5, 2025 is dismissed. Order No. 25-UI-294960 remains undisturbed.
