EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0442

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 17, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits from November 17, 2024, through February 1, 2025 (decision # L0007906996). Claimant filed a timely request for hearing. On February 24, 2025, ALJ Murray conducted a telephone hearing at which claimant initially appeared but was disconnected before the close of testimony. On February 27, 2025, ALJ Murray issued Order No. 25-UI-284415, modifying decision # L0007906996 by concluding that claimant was discharged for misconduct and disqualified from receiving benefits effective September 29, 2024. On March 19, 2025, claimant filed an application for review with the Employment Appeals Board (EAB).

On April 23, 2025, EAB issued EAB Decision 2025-EAB-0184, remanding the matter for further development of the record to provide claimant an opportunity to fully present his case. On June 25, 2025, ALJ Murray conducted another hearing, and on June 27, 2025 issued Order No. 25-UI-296147, concluding that claimant quit work without good cause and was disqualified from receiving benefits effective September 29, 2024. On July 17, 2025, Order No. 25-UI-296147 became final without claimant having filed an application for review with EAB. On July 18, 2025, claimant filed a late application for review of Order No. 25-UI-296147 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written argument, has been marked as EAB Exhibit 2, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 25-UI-296147, mailed to claimant on June 27, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-296147 at 5. Order No. 25-UI-296147 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 17, 2025 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-296147 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-296147 was due July 17, 2025. Because claimant did not file his application for review until July 18, 2025, the application for review was late. Claimant included a written argument with his application for review. However, claimant's written argument did not describe circumstances preventing him from filing the application for review on time. *See* EAB Exhibit 2. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 18, 2025 is dismissed. Order No. 25-UI-296147 remains undisturbed.
