EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0467

Affirmed No Disqualification

PROCEDURAL HISTORY: On February 11, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective December 29, 2024 (decision # L0009297081). Claimant filed a timely request for hearing. On March 19, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 31, 2025. On March 31, 2025, claimant failed to appear at the hearing, and ALJ Gutman issued Order No. 25-UI-287727, dismissing claimant's request for hearing because she failed to appear. On April 1, 2025, claimant filed a timely request to reopen the hearing.

On July 8, 2025, OAH served notice of a hearing scheduled for July 24, 2025 on whether to grant claimant's request to reopen and, if so, the merits of decision # L0009297081. On July 24, 2025, ALJ Scott conducted the hearing, and on July 28, 2025 issued Order No. 25-UI-298848, granting claimant's request to reopen and reversing decision # L0009297081 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the discharge. On July 30, 2025, the employer filed an application for review of Order No. 25-UI-298848 with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-298848's findings of fact, reasoning, conclusions that claimant's request to reopen should be allowed, and that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the discharge. Order No. 25-UI-298848 is **adopted**. *See* ORS 657.275(2).

¹ Decision # L0009297081 stated that claimant was denied benefits from December 29, 2024 to January 10, 2026. However, decision # L0009297081 should have stated that claimant was disqualified from receiving benefits beginning December 29, 2024 and until she earned four times her weekly benefit amount. *See* ORS 657.176.

DECISION: Order No. 25-UI-298848 is affirmed.
