

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0474

Affirmed
Disqualification

PROCEDURAL HISTORY: On May 7, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer with good cause and was not disqualified from receiving benefits based on the quit (decision # L0010628052). The employer filed a timely request for hearing. On July 24 and 25, 2025, ALJ Chiller conducted a hearing, and on August 1, 2025 issued Order No. 25-UI-299392, concluding that claimant quit without good cause and was disqualified from receiving benefits effective March 9, 2025. On August 4, 2025, claimant filed an application for review with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: With her application for review, claimant submitted copies of Exhibits 1 through 7, which were admitted into the hearing record at the hearing on July 25, 2025. (July 25, 2025 Hearing at 20:00; Order No. 25-UI-299392 at 1). EAB considered the entire hearing record, including Exhibits 1 through 7, when reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. Order No. 25-UI-299392's findings of fact, reasoning, and conclusion that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective March 9, 2025. Order No. 25-UI-299392 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-299392 is affirmed.
